- Board Trustee report – we have a Learning Facilitator (not full time but a .8 position) to support adult learning. The focus is to support the school goal of actualizing the PSSD "Our Classroom". She will provide broad/general information and can participate in co-planning or co-teaching as she is able to cover a classroom so teachers can collaborate with each other. Fifty percent of the parents responded to the survey regarding the future plans for our children. PSSD is doing the same ticket sales as last year with \$30 for every \$100 ticket going to the school.
- Fundraising/Hot Lunch report:  
The pizza sale was good, we sold 583 pizzas, generating \$1,166 profit with this being the best one so far for sales. There were more issues this time with delivery and distribution. Rana has already spoken to the manager and we are hoping tomorrow's lunch will be better. We will possibly do another hot lunch at the beginning of December.

- SCC Fall Orientation – they focused on the Prairie Spirit Classroom and student engagement.
  - Read Saskatoon – Look into the possibility of doing a literacy night with READ Saskatoon. These nights are more geared toward Grades 4 and 5 and are approximately \$200 (possibly additional expenses because we are out of town). Can comfortably have 250 students participate. Can also do a book exchange with parents. Danielle will look into this program and bring more information to the next meeting.
- T-Shirt Sale – encouraging school spirit by selling t-shirts. Inquiring if we would be able to assist by manning a table during the parent teacher conferences. We have agreed to do our best and have people assist at a table, we may have some spots that are vacant but for the most part we should be able to do this.
